

Negotiations Updates

Howard University and DCNA Agree on New Contract Covering Licensed Health Care Professionals

On May 11th, DCNA and HU/HUH reached tentative agreement on a new collective bargaining agreement. The agreements runs until June 30, 2024. The parties continue to thoroughly review the entire contract and expect to sign the agreement over the next few weeks. The parties also plan to have their first Staffing Committee meeting in late July or early August.

District of Columbia Government

As previously reported here, the District of Columbia and DCNA have agreed to raises for the nurses under the Department of Behavioral Health and Compensation Unit 13, with 9% pay increases plus a 3.5% bonus and bonuses each year in addition to the annual pay increases.

DCNA has learned that the Mayor has forwarded the Agreements to the DC Council for its review and passage. It is expected that the DC Council will take up the resolution seeking passage of the Agreements in July.

DCNA Attends Historic AFL-CIO Convention





From June 11-15. Edward Smith. Executive Director, attended the AFL-CIO Convention, as a guest of the National Nurses United. During this Convention, the delegates elected Liz Shuler as the first female President, AFL-CIO. In addition, delegates elected Fred Redmond as the first African-American Secretary/Treasurer of the AFL-CIO. President Joe Bien addressed the unions and made clear that he supports labor and all of our organizing efforts. Stacey Abrams, who is running for Governor in Georgia, gave a

rousing speech as well.

the house of labor," stated
Smith.

The AFL-CIO also passed numerous resolutions, including the support of

medicare for all and supporting efforts to address gender inequity and climate change. In fact, Bonnie Castillo, Executive Director, NNU, introduced the resolution on gender inequity. We also attended a rally to support workers at the
